


The American Pet Products Association reported that 11.38 million households in the U.S. have gotten a new pet during the pandemic, and according to The Washington Post, rescue shelters are seeing double the typical number of requests to adopt dogs since the start of the pandemic. 3 out of 4 pet owners reported that spending time with a dog, cat, or other animal helped reduce stress and increased their sense of well-being, which is why we are also seeing more animals traveling with their humans.

Travelers are looking to bring their beloved pets on new adventures now that destination vacations are back on. We have recognized the growth in online searches for dog-friendly attractions, which is why we want to help increase the focus on engaging this demographic. Through research we see an increase in popularity.

Through Google Trends we have collected this data:

- Dog-friendly travel: 128% increase
- Dog-friendly destinations: 67% increase
- Dog-friendly hotels: 24% increase
- Dog-friendly restaurants: 90% increase
- Dog-friendly activities near me: 141% increase
- Dog-parks near me: 168% increase



# **VENDOR GUIDELINES**

#### **MISSION STATEMENT:**

- Support local businesses by providing a venue to directly promote and market their goods and/or services and bring business into downtown Tahlequah.
- Increase animal welfare by providing a venue for an adoption event, onsite vet clinic, and educational pet classes.
- Create a family-friendly event for families in the local area to gather.
- Support, revitalize, and grow downtown Tahlequah by increasing foot traffic and patronage to the downtown area.
- Exhibit and showcase how "pet-friendly" the City of Tahlequah is to visitors.

FIDO FEST is operated by Tour Tahlequah. The following rules and regulations apply. Tour Tahlequah may amend, delete, or modify its policies, rules, and regulations.

Tour Tahlequah expects all vendors and volunteers to act in a professional manner to foster a spirit of community, camaraderie, and cooperative involvement.

#### PRODUCT POLICIES AND GUIDELINES:

#### Food & Agricultural Products

- Vendors in this category MUST review the current Cherokee County regulations pertaining to all food products.

- Vendors wanting to sell homemade pet food or treats must have a current Commercial Feed License and follow ALL Oklahoma Commercial Feed Laws and Rules.

#### ALL LICENSES OR CERTIFICATES MUST BE IN ORDER AND AVAILABLE ON REQUEST.

# **VENDOR GUIDELINES CONT...**

#### Arts & Crafts

• Preference will be given to vendors with products handcrafted in the Tahlequah area and "Made in Oklahoma" products. Merchandise will be subject to approval by Tour Tahlequah.

#### Animals & Pets

• No vendors (besides our authorized animal shelter vendors) will be permitted to sell, give away, exchange, adopt out, or give ANY animals as prizes under ANY circumstances.

#### MARKET SPACE & RESERVATIONS:

- Vendors are asked to fill out an application each year. Pet products will be given priority over other product categories. Selection will be based on quality, and contribution to the desired market mix.
- Tour Tahlequah does not offer exclusive rights to vendors to sell any one product.
- Before reservations are secure, selected vendors must send fees with completed and signed application/contract, and where required provide the necessary Cherokee County Health Department certificates and licenses.

#### Selling Space

- Each vendor will be assigned a 10 x 10 (10' wide and 10' feet deep) space.
- Tour Tahlequah have final determination on vendor placement, taking into consideration product mix, customer flow, and market appearance.
- Booth assignments are not transferable.
- Vendors will provide their own tables, canopies, signs, and other desired display materials.
- All booth rentals are based on one vendor per rental space. Multiple vendors may not share a booth. One business name and vendor per canopy please.
- If you reserve your booth and discover that you cannot fulfill this commitment, please let us know ASAP and we will assign your space to another vendor. Please do not offer your space to another vendor.
- To keep our vendors and our shoppers safe from harm in our frequent windy conditions we require that all canopies are sufficiently weighted to keep the covering in place. For standard canopies, approximately 25 pounds of weight is necessary for each leg. Canopy weights must be in place from set-up through take-down.
- Electrical outlets: please contact Tour Tahlequah for a special space location.
- Please do not play radios or use other sound generating electronics during market hours except by prior approval from Tour Tahlequah.

# **VENDOR GUIDELINES CONT...**

#### **BOOTH FEES:**

- Attached you will find the application for the 2023 FIDO FEST event. Please fill out the application with the non-refundable payment to secure your booth.
- \$100 will reserve your space for the event.
- The above fee structure is for one 10 x 10 booth space.

#### PUNCTUALITY/SET UP/TAKE DOWN:

- FIDO FEST is an all day event but booths will open at 8:00am. Vendors who do not show by 7:30am for set up or cancel after 12:00pm the preceding Friday will lose their space and forfeit their fee. Empty booth spaces will be filled.
- Please arrive no later than 7:30am.
- Vendors may drive to the market area perimeter with their vehicles for the purpose of unloading only (except vendors with parking rights.) No vehicles will be allowed on the grass.
- PLEASE UNLOAD MOVE YOUR VEHICLE AND THEN SET UP. VEHICLES NEED TO BE REMOVED FROM THE BOOTH LOCATION BY 7:30am.
- A VENDOR MAY NOT BEGIN SETTING UP HIS OR HER BOOTH SPACES UNTIL HIS OR HER VEHICLE IS MOVED OFFSITE.
- PLEASE DO NOT PARK ON MORGAN ST. BETWEEN WATER AVE. AND MUSKOGEE AVE.
- All vendors are required to remain at their booth spaces until closing at 7:00pm. At 7:00pm vendors shall cease selling and begin taking down their booth spaces. Vehicles will be allowed to enter the FIDO FEST perimeter at 7:00pm, not before.
- Each vendor is responsible for cleaning his/her area to the satisfaction of Tour Tahlequah. This includes removing all trash and any debris generated by the sale of their product. All vendors must bring containers suitable for waste removal.
- Parking Map is attached.

#### CREDIT CARD SALES:

• Please provide your own method of accepting credit cards.

# **VENDOR GUIDELINES CONT...**

#### SIGNAGE:

- Booth area: each booth space must prominently display a sign clearly identifying the business or organization by name.
- Product price signage: signs identifying the names and prices of all products sold must be in place by 12:30pm on the day of the event. All product descriptions must be accurate.
- Organic labeling: vendors advertising "Organic", "Unsprayed", "Natural", etc. products are not required to be certified by any recognized certification agency. However, state law to those who have in fact been certified by the Department of Agriculture restricts use of the phrase "Certified Organic". All vendors are required to advertise truthfully and to respond to customers' questions in a kind manner.
- Weights, measures and produce labeling: please provide clear signage for pricing of bunch items or packages. Pre-packaged products must be labeled with the quantity and/or amount and need to include the name, address and/or phone number of the grower and vendor.

#### **PROFESSIONALISIM & COURTESY:**

- All vendors are required to wear shoes and shirts.
- The entire event area is a NO SMOKING ZONE.
- For any event questions, please direct the customers to the FIDO FEST information booth.
- Your courtesy is appreciated to make FIDO FEST a success for all!

#### LIABILITY:

- Tour Tahlequah and its members are not responsible for any vendor loss or damage or injury.
- Each vendor is required to have liability insurance and submit proof of liability insurance with the application packet.
